

Advanced Diploma of Accounting

National Code: FNS60215; **CRICOS code:** 088168D

Description:

This qualification is designed to reflect the role of individuals working in accounting and seeking professional identification and senior-level accounting job roles. Work functions in this occupational area are subject to regulatory requirements.

Entry Requirements:

1. English language/literacy/numeracy requirements:

International students applying either off-shore or on-shore will require:

- i) either a minimum IELTS test score of 5.5 or 65 score in TOEFL or equivalent; Results older than two years are not acceptable, **OR**
- ii) to provide evidence that they have studied in English for at least five years in Australia, Canada, New Zealand, Republic of Ireland, South Africa, United Kingdom or United States, **OR**

2. Academic requirements:

For the direct entry into this qualification, both international and domestic students should have satisfactorily completed the Australian Year 12 equivalent or Diploma level or higher. However, for students with packaged courses, they should have completed the prior qualifications for entry into this qualification. The entry requirement can be met by evidence of equivalent competency to either of the above through recognition of prior learning (RPL).

3. Age requirements:

International students must be 18 years of age or above at the time of their course commencement at the Institute. For under 18 students, they should have acceptable arrangements for their accommodation, support and general welfare for the duration of the student visa or until they turn 18 (whichever happens first) as per the ESOS Act and National Code. In case of domestic students, if the applicant has not completed Year 12 or Diploma of Accounting or higher, the applicant must successfully complete Hamro college's language and numeracy test, be aged 18 or over and demonstrate through an enrolment interview, either in person or by phone, that they have the skills and ability to succeed in their chosen course.

Pathways to and from information:

Preferred pathway for entering into this qualification would be Diploma of Accounting. After completing this qualification, participants may seek relevant employment opportunities as a senior

accountant or similar role, or take any other training options. A further learning pathway could be Bachelors of Accounting or any Bachelors level qualification in financial services industry.

Course structure:

This qualification will be completed in 78 weeks (including 18 weeks of breaks and holidays). Students will need to complete 14 units of competency (3 core and 11 elective) to attain the qualification.

Course delivery:

Students appear in face-to-face tuition of a minimum of 15 hours per week within an institution-based environment plus five hours per week through on-line delivery. Delivery of this qualification will combine theory-based material and practical sessions involving small discussion groups, individual and team activities and practical projects. Throughout the training program participants

- Case study/written report
- Projects/written assignments
- Presentations/observations
